Course description:

Overview of the principles of plant health and pest management applied to the production of plants and other commodities in controlled environments, including greenhouses, urban vertical agriculture, high tunnels, hydroponic systems and interiorscapes.

Course objectives:

- 1- Understand the main pests' challenges when growing plants and other commodities in controlled environments.
- 2- Understand the use of plant health and ecological concepts in the development and application of integrated pest management (IPM) in controlled environments.
- 3- Gain an appreciation of the different approaches necessary to maintain plant health in different controlled environment settings.

Course structure:

<u>Lectures</u>: For this class the lectures will be recorded and will be made available via computer through Carmen (https://carmen.osu.edu/). The topics are listed in the syllabus. The lectures and exercises have the equivalent of the material that would be presented on two 75-minute classes per week. Therefore, please plan accordingly to spend adequate time viewing the lectures. Material will be added to Carmen Wednesday each week.

Exercises and assignments: Assignments and exercises will be provided throughout the duration of the class. These will be posted on Carmen and will explicitly show the due date. When possible, examples and/or rubric or guidelines will be made available. All assignments and exercises need to be submitted using Carmen drop boxes that will be set up for such purpose. Please plan on submitting these in an appropriate format (Word, Excel, pdf). Each assignment will have suggestions regarding accepted formats for submission.

Lecture quizzes:

Some lectures will be associated with a quiz that must be taken using Carmen. The quiz will open at the same time as the lecture and will remain open for a week. The deadlines will be posted on Carmen. Please make sure to take the quizzes at an appropriate time before the deadline.

Assignments or Exercises:

The goal of this presentation is to help the student understand how to support/refute ideas based on findings from searches from primary literature about integrated pest management. The presentation will be done using Zoom. Students will prepare their oral presentation using PowerPoint or similar and will connect with Dr. Canas at an agreed time. Once in Zoom, students will be able to give their presentation.

Final project:

A rubric for the final project will be posted on Carmen the 3rd week of classes. The goal of this project is to help the student understand how to develop a step by step guideline to start a biological control program.

The following are my expectations for how we should communicate as a class. Above all, please remember to be respectful and thoughtful. There will be two types of discussion: weekly discussions using Carmen, and live discussions using Zoom.

- Weekly discussion using Carmen discussion board: Participation in class discussions is mandatory (see grading). I will expect each student to post at least two comments on each week's discussion board. These could be questions or comments in response to a question or comment. In addition, I will prepare a schedule during the first week of class when a particular student(s) will be the leader(s) of the discussion for that week. As leader of the discussion, the student will be in charge of initiating the discussion if needed, or to stimulate the discussion to continue. I will provide an example during the first week. Write your comments as if you were writing a research paper, you should remember to write using good grammar, spelling, and punctuation. Informality (including an occasional emoticon) is fine for non-academic topics. For some discussions we may use Flipgrid (https://flipgrid.com/d1fed72d). I will provide instructions during the first week of class about the use of this tool.
- Live discussions via Zoom (scheduled, see syllabus): I will expect each student to participate in live discussions (3 in total). The time will be selected during the first week. The students will connect using Zoom (specific details will be posted on Carmen) and will discuss issues relevant to the class. Here you will have a chance to ask any questions you may have about the course. The discussion will last 20 minutes.
- **Tone and civility**: Let us maintain a supportive learning community where everyone feels safe and where people can disagree amicably. Remember that sarcasm does not always come across online.
- **Citing your sources**: When we have academic discussions, please cite your sources to back up what you say. (For the textbook or other course materials, list at least the title and page numbers. For online sources, include a link.)
- **Backing up your work**: Consider composing your academic posts in a word processor, where you can save your work, and then copying into the Carmen discussion.
